Eischens stated that thank yous were received last year from all the organizations donated to and requests were received from everyone this year except the Sybil Lake Cemetery. Discussion was held regarding the fact that it was less expensive to give them a donation that to end up taking over the maintenance of the cemetery. Eischens also stated that the Board had been approached to donate to the Vergas Veteran's Memorial that is being done. Discussion was held as to whether or not to donate and how much. Consensus was that, if built as planned, would be a good teaching tool about the military. Ray Sonnenberg made a motion to donate \$800.00, a one-time donation to the Vergas Veteran's Memorial. Ryan Bruhn second. All in favor Motion carried. Ray Sonnenberg made a motion to donate the following funds:
