

Hobart Township Monthly Meeting
June 11, 2024

Supervisor Sonnenberg called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited.

Hoffmann made a motion to approve the Minutes from the May 2024 meeting. Ehlke second. All in favor. Motion Carried.

Hoffmann made a motion to approve the Treasurer's report as presented. Ehlke second. All in favor. Motion Carried.

Hoffmann made a motion to approve the disbursements as presented. Ehlke second. All in favor. Motion Carried.

Joan Stenger presented a petition to vacate a plated unused road corridor in the Herbs Ridge plated development. Since the road corridor is not used as a road the board approved the vacation of the unused road corridor. A resolution was passed.

Some of the residents that live on Long Shore Rd/Trl asked the board if dust guard was going to be used on Long Shore Rd/Trl this year. Supervisor Hoffmann stated that he had called the residents of Long Shore Rd/Trl as a follow up from the January meeting. Hoffman stated that he was able to reach 15 residents and had the following results: 6 residents stated they did not want dust guard, 5 stated that did want dust guard, and 4 stated that they would support either decision. After discussion the board determined that dust guard would not be used on that road. Hoffman made a motion to not apply dust guard to Long Shore Rd/Trl. Ehlke second. All in favor. Motion Carried.

Larae Danielson stated that a section of East Rose Lake Rd had damage from the recent rain and is in need of repair. Supervisor Sonnenberg will look at the road after the meeting.

Gerg and Kim Lyon who own property at 36709 E Rose Lake Rd asked the board for permission to bore a 2-inch pipe 10 feet under a section of E Rose Lake Rd so they could place their drain field on their property across the road. Since that section of road is not maintained by the township and the township has no plans to take over that section of road, permission was granted with the stipulation that the township has no responsibility and the owner or any future owner of the property would be responsible for any damage to the road or damage to the pipe during or after installation. Clerk Berstler will draft a letter to the county.

Missy Daggett representing the Wymer/Graham Lake Association expressed concern with people accessing the lake from the section West Wymer Lake Rd that runs between the two lakes causing

congestion by parking on the shoulder of the road. The board tabled the discussion till the July monthly meeting.

Supervisor Ehlke stated that he checked into the mail box that is located at the intersection of Co Hwy 4 and 345Th Ave. The mail box is too close to the turn off onto 345Th Ave. and causes issues with snow plowing and anyone turning with a trailer. The county will move the mail box for \$75.00. The board stated that they would pay the \$75.00 to eliminate the issue. Supervisor Ehlke will contact the post master and mail box owner to get permission to move the mail box.

Since there was no further business to come before the Board, Chairman Sonnenberg adjourned the meeting.
