

Hobart Township Monthly Meeting
September 10, 2024

Present: DuWayne Sonnenberg, Larry Hoffmann, Scott Ehlke, Kathy Glawe, Russ Berstler, Torey Sonnenberg, Donna Winkels, Dani Winkels, Dan Bucholz, and Steve Knuttila

Chairman Sonnenberg called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited.

Hoffmann made a motion to approve the Minutes from the August 2024 meeting. Ehlke second. All in favor. Motion Carried.

Hoffmann made a motion to approve the Treasurer's report as presented. Ehlke second. All in favor. Motion Carried.

Hoffmann made a motion to approve the disbursements as presented. Ehlke second. All in favor. Motion Carried. It was noted that the remaining ARAP funds were used for road maintenance.

Steve Knuttila at 36343 S Rose Lake Rd brought a concern about drainage and water pooling in the ditch. The board will meet on site Thursday September 12, 2024 at 1:00 PM to review the ditch drainage.

Dan Bucholz District 1 commissioner gave an update to the board on the retirement of Wayne Stein, county auditor, and an update on the current status of the EMS from the county point of view.

An email was received from Joy Stumbo 34967 Freedom Flyer Rd about the steep drop off on the corner. It was suggested that the reason for the drop off was due to traffic cutting the corner causing the road to migrate over time. It was decided that no work would be done on the road this year and to review the corner at the 2025 Road Tour.

The board reviewed the draft letter from the attorney concerning the noncompliant approach installed at 51115 W Wymer Lake Rd. Supervisor Ehlke made a motion to approve sending the letter with a minor correction. Supervisor Hoffmann seconded. All in favor motion carried. Clerk Berstler will contact the attorney.

The board approved the publication of the Township's Snow Removal policy in the local paper in November. Clerk Berstler will draft a notice for the board to review at the October meeting.

Torey Sonnenberg stated that mowing of the ditches had started. Chairman Sonnenberg stated that he informed Cody not to cut the ditches on E Wymer lake Rd, and Black Dimond Rd until after weed spraying was completed.

Since there was no further business to come before the Board, Chairman Sonnenberg recessed the meeting at the hall, the meeting will continued with the supervisors meeting at 36343 S Rose Lake Rd on Thursday September 12, 2024 at 1:00 PM to review ditch drainage.
