Hobart Township Monthly Meeting July 9, 2024

Chairman Sonnenberg called the meeting to order at 7:00 pm. The Pledge of Allegiance was recited.

Hoffmann made a motion to approve the Minutes from the June 2024 meeting. Ehlke second. All in favor. Motion Carried.

Hoffmann made a motion to approve the Treasurer's report as presented. Ehlke second. All in favor. Motion Carried.

Hoffmann made a motion to approve the disbursements as presented. Ehlke second. All in favor. Motion Carried.

A group representing the residents of Wymer/Graham Lake voiced concerns with vehicles parked along the section of West Wymer Lake Rd that runs between the two lakes. The vehicles restrict traffic flow through the area causing a potential safety issue. After some discussion it was suggested that a possible solution would be to provide a place for vehicles to park. The Board will consider this option. The Board agreed to replace the missing No Parking signs.

George Massey expressed his concerns with the Boards decision to not apply dust guard to Long Shore Rd/Trl. Supervisor Hoffmann explained how the Board reached the decision. George asked to see the MSDS for the product applied to the roads (magnesium chloride). Clerk Berstler will contact Corbin Excavating and Dust Control for the information.

The Township received a letter from the Otter Tail County Attorney office regarding a court case for an accident at the intersection of Co Hwy 60 and South Rose Lake Rd that damaged a stop sign. It was determined that the Stop sign was the responsibility of Otter Tail County. Supervisor Ehlke will contact the county to have the sign replaced. Clerk Berstler will contact the county attorney office to inform them this is a county issue.

Supervisor Ehlke informed the Board that the mail box located at the intersection of Co Hwy 4 and 345Th Ave discussed at the June meeting has been relocated.

Chairman Sonnenberg stated that he found a company that will spray the Township Road right-of-ways for a cost of \$130.00 per hour plus cost of the chemicals. Chairman Sonnenberg and supervisor Ehlke will drive the roads and map out potential areas for weed control.

Due to the Primary Elections being held on Tuesday August 13, 2024 the next monthly board meeting will be held on Monday August 12, 2024 at 7:00pm.

Since there was no further business to come before the Board, Chairman Sonnenberg adjourned the meeting.
