Sonnenberg made a motion to have Newling Asphalt Services do the sealing. Hoffmann second. All in favor motion carried.

An e-mail was received from Lyle Krieg stating that there is a huge dip in the road on Adams Point Road that occurs every year ever since a new culvert was put in some years ago. The supervisors stated that they will look at it.

An Approach permit was received from Justin and Sally Clemenson for an approach to be installed on 34071 Scalp Trail, Frazee. Hoffmann stated that he will look at the proposed approach location.

Donations from the annual meeting were discussed. The supervisors agreed to make the donations as approved by the electors at the annual meeting. Claims will be made and checks written at the May meeting.

Putting funds from the Fire Fund into a Certificate of Deposit was discussed. Reasoning is that money being set aside for new fire trucks could earn interest. Hoffman made a motion to put some of the funds from the Fire Fund into a CD at Vergas State Bank, Sonnenberg second. All in favor motion carried.

Supervisor Hoffmann stated that the annual road tour should be completed before the May board meeting. All supervisors agreed. Date and time was set. Participants will meet at the town hall on Friday May 5th at 8:00am. Participants will be notified of any changes in date or time.
